



## Construction Updates for October 7

### Tree Clearing and Other Work on Fall River Secondary Main Line

This week and next, the contractor continues with tree clearing, erosion control, and survey work occurring along the Fall River Secondary Line right-of-way. Tree clearing is anticipated to begin next week at the Fall River Depot site.

To ensure safe and unobstructed service, the MBTA needs a cleared right-of-way. Because the Phase 1 tracks have seen very limited use, overgrowth has occurred. Tree cutting along the railroad corridor will be necessary for construction. To maintain the safety and efficiency of the railway, trees and heavy brush obstructing the right-of-way will not be replaced.

  - Fall River Secondary Line between Adams Lane in Berkley and Beechwood Road in Assonet
  - Fall River Depot site, 825 Davol Street, Fall River
- **Dates/hours of work:**
  - Current week: Monday, Oct. 5 through Friday, Oct. 9, 7:00 AM to 3:30 PM.
  - Next week: Tuesday, Oct. 13 through Friday, Oct. 16, 7:00 AM to 3:30 PM (no work Monday, Oct. 12 due to holiday).

Ongoing MBTA work may be disruptive to local residents, but no significant impacts to local traffic, businesses or properties are anticipated. Crews will be using various pieces of heavy equipment and trucks along the railroad right-of-way. While the project will seek to minimize construction-related impacts to communities, low to moderate noise levels and vibrations will be generated.

### Building Demolitions

Demolition of 61 Pearce Street in Fall River is anticipated to be completed this week.

### **Bridge Replacements and Associated Track Work**

Punch list work and final inspections will continue for the bridge replacements and related track work at the North and South Cotley railroad bridges in Berkley, the Cedar Swamp railroad bridge in Lakeville, and the Fall Brook railroad bridge in Freetown between 7:00 AM and 3:00 PM on weekdays.

### **Culverts**

Punch list work and final inspections will continue intermittently for the 46 culvert replacements and related track work, wetland reconstruction, and Tarkiln Hill Road grade crossing improvements along the South Coast Rail Phase 1 Corridor on the New Bedford Main Line, Fall River Secondary, and Middleborough Secondary in the communities of Berkley, Fall River, Freetown, Lakeville, Middleborough, New Bedford, Raynham, and Taunton between 7:00 AM and 4:00 PM on weekdays. The remaining work is not expected to be disruptive to local residents or to impact access to local businesses or properties.

*Please note that although the South Coast Rail Early Action work at the Tarkiln Hill Road Grade Crossing is largely complete, the City of New Bedford is also carrying out work in the Tarkiln Hill Road location for MassDOT Project #606709 (King's Highway Reconstruction).
